

EZ Buy Referral Programme

Terms & Conditions

1. The **EZ Buy Referral Programme** is open to **Shaklee Independent Distributors (SIDs)** only.
2. To qualify for the **RM30 e-Discount Voucher (RM30 eDV)**, SIDs must successfully refer **three (3) new customers** who make their purchase through their personalised EZ Buy Link, **within the same calendar month**.
3. Referred customers must be **non-registered Shaklee SIDs** at the time of purchase.
4. A referral is considered successful only when the **referred customer's order** has been **confirmed and fully paid**. Orders that are cancelled, refunded, returned, or deemed invalid will not qualify as successful referrals.
5. **A referred customer will count as only one successful referral per calendar month**, regardless of the number of qualifying purchases made during that month.
6. There is **no limit** to the number of referrals. SIDs may earn **multiple RM30 eDVs**, with **one (1) RM30 eDV awarded for every three (3) successful referrals achieved within the same calendar month**.
7. **Referral counts are calculated on a calendar month basis** and reset on the first day of each calendar month. Any referral count that does not reach the minimum requirement of three (3) successful referrals by the end of the month will expire and will not be carried forward to the following month.

RM30 e-Discount Voucher (RM30 eDV)

8. The **RM30 eDV** will be issued by the **10th day of the following month** after all qualifying referral purchases have been successfully confirmed and paid.

10. The **RM30 eDV** is valid with a **minimum purchase of RM 300** in a single transaction.
11. The **RM30 eDV** is valid for **sixty (60) days** from the date of issuance.
12. The **RM30 eDV** is **not redeemable** on promotional products, Sales Aids, or Shaklee Style premium items.
13. The **RM30 eDV** is not entitled to UV and PV. UV and PV will be deducted proportionately based on the voucher value redeemed.
14. Multiple **RM30 eDVs** can be combined in a single transaction, based on the minimum purchase requirement.
15. If the **RM30 eDV** is not claimed within the redemption period, it will be forfeited, and no replacement, extension, or compensation will be provided.
16. The **RM30 eDV** is **non-transferable**, cannot be exchanged for cash, and cannot be sold or assigned to another person.
17. Shaklee Products (Malaysia) Sdn Bhd reserves the right to amend, suspend, or terminate this program and its terms and conditions at any time without prior notice. In the event of any dispute, Shaklee Malaysia's decision shall be final and binding.
